FAQ on all three:

You cannot apply if you are already under repayment through another obligation program.

*Must be using RN in a behavioral health setting.

If you apply for one pot and another cycle opens, I don't think you can apply again until you find out if you are denied.

Full time means 40 hours: (8 hours allowed for teaching, 8 hours allowed for administrative work; all other hours must be in practice)

*Priority is given to practitioners that have completed MAT /Data 2000 Waiver training.
